Concessions may be inspected on or during the event by the Ogle County Health Department and Polo Town and Country Days Committee. Vendors are responsible for any applicable sales tax. Vendors may set up on Wednesday June 12th, 2024 AFTER 5:00 pm and must be completely setup and in place by Thursday, June 13<sup>th</sup>, 2024 at NOON. All vendors are to be dismantled and off the streets by 8:00 pm Sunday June 16<sup>th</sup>, 2024. Ice will be available for purchased through Polo Town and Country Days.
